



Desert Classic Commercial Vendor Contract Dec. 2-5, 2021 WestWorld, Scottsdale

The Desert Classic All Arabian Horse Show is the third largest Arabian show in Region 7 and the state of Arizona. It is a perfect time for some early holiday shopping.

For your convenience, we will begin set-up in the Equidome at 9am on Wednesday, December 1, 2021. All exhibits must be completely removed after the show ends on Sunday, December 5, 2021 unless you have permission from WestWorld for a Monday teardown and departure. Please complete the attached Commercial Vendor form and remit with the appropriate fees as early as possible. Priority space assignments will be given to previous vendors.

Exhibitors who win a First place or a Championship are awarded Desert Classic Show vouchers in the amounts of \$10.00 and \$15.00. These vouchers may be used the same as cash for any merchandise or service from any vendor, excluding food. If you have a local outlet or website, the vouchers may also be used there. The Desert Classic show will issue a check to you upon presentation of any voucher you have accepted.

The City of Scottsdale has a liability insurance requirement. You must carry insurance to cover your business during the Desert Classic show. Please contact WestWorld (480) 312-6806 for more information and further requirements.

Vendors agree to hold harmless Desert Classic Directors, Show Management, owner and operator of show facility from claims, losses and damages arising from any injury, death or damages to property for any reason.

The Arizona Department of Revenue (ADOR) now handles licensing, reporting and collection of transaction privilege sales tax for all cities in Arizona. If you have a transaction privilege (sales) tax obligation, you will have to make sure that you have an ADOR TPT license and that it has the region code of Scottsdale (SC) listed. Vendors/Exhibitors agree to man their booth(s) during show hours, 8:30am—6pm, or until after the last class of the day, whichever comes first. Vendors/Exhibitors shall not dismantle any portion of their booth(s) before the end of the last class on Sunday, December 5, 2021.

No assignments or subletting of all or any portion of assigned exhibit space.

Design of exhibit must not extend into aisles or adjoining exhibit space or obstruct view of adjoining space.

Vendors/Exhibitors will take all necessary precautions to insure the safety of their personnel, other exhibitors and customers on the premises and shall comply with all applicable provisions of federal, state and municipal safety laws, building codes and ordinances to prevent accidents and/or injury.

Show management reserves the right to prohibit any exhibit which it deems to distract from the overall character of the show.
