



Desert Classic Commercial Vendor Contract December 4-6, 2026 WestWorld, Scottsdale

The Desert Classic All Arabian Horse Show is the third largest Arabian Horse show in Region 7 and the state of Arizona. It is a perfect time for people to enjoy some early holiday shopping.

For your convenience, vendor set-up will begin at 9am Thursday, December 3, 2026. All exhibits must be completely removed after the conclusion of classes on Sunday, December 6, 2026, unless you have permission from WestWorld for a Monday, December 7 teardown. Please complete the attached Commercial Vendor form and remit with the appropriate fees as early as possible. Priority space assignments will be given to previous vendors.

Exhibitors who win a First place or a Championship are awarded Desert Classic Show Vouchers in the amounts of \$10.00 and \$15.00. Patron vouchers are in the amount of \$15.00 each and Volunteer vouchers will be \$20.00 each. These voucher may be used as cash for any merchandise or service from any vendor. If you have a local outlet or website, the vouchers may be used there also. The Desert Classic Show will issue reimbursement checks to you upon presentation of any accepted vouchers.

The City of Scottsdale has a liability requirement. You must carry insurance to cover your business during the show. Please contact WestWorld at 480-312-6806 for information.

Vendors agree to hold harmless any Desert Classic Director, Show Management, owner, operator of the show facility from claims, losses and/or damages arising from any injury, death or damages to property or person for any reason.

The Arizona Department of Revenue (ADOR) now handles licensing, reporting and collection of transaction privilege sales tax for all cities in Arizona. If you have a transaction privilege (sales) tax obligation you will have to make sure that you have an ADOR-TPT license and that it has the region code of Scottsdale (SC) listed. Vendors/Exhibitors agree to man their booth(s) during all show hours, 8:30am to 6pm or until the last class of the day has finished. Vendors/exhibitors shall not dismantle their booth(s) before the end of the last class on Sunday, December 6, 2026.

No assignments or subletting of any or all portions of assigned exhibit space.

Design of exhibit must not extend into aisles or adjoining exhibit space or obstruct view of adjoining spaces.

Vendors/Exhibitors will take all necessary precautions to insure the safety of their personnel, other exhibitors and customer on the premises and shall comply with all applicable provisions of federal, state and municipal safety laws, building codes and ordinances to prevent accidents and/or injury.

Show Management reserves the right to prohibit any exhibit which it deems to distract from the overall character of the show.
